

# MEMBERS BADGE DRAW

## Terms & Conditions

### Promotional Period

1. The promotion will commence from Monday 16<sup>th</sup> March, 2026 and the following terms and conditions are in place until the expiry of the above Authority No. (15 April 2027) or on submitting an amendment application to NSW Fair Trading, whichever comes first.

### Member Badge Draw Details

2. Entry is open to members of St Marys Rugby League Club over the age of eighteen years, after legal entrance to the Club.
3. Patrons must become a member of the Club before 3pm on Wednesdays and 1.30pm on Sundays to be eligible to claim the prize on that night/day.
4. The Members Badge Draw will be conducted on Wednesdays at 7pm, 8pm and 8.30pm and Sundays at 2:30pm, 4:30pm and 6:30pm.
5. The cash jackpot will commence at \$20,000 (Twenty Thousand Dollars) and will increase by \$1,000 (One Thousand Dollars) on each Wednesday and Sunday draw day until claimed.  
If the jackpot reaches \$100,000 (One Hundred Thousand Dollars) without being claimed, it will remain capped at \$100,000 until won.  
Once the jackpot reaches \$100,000 and remains unclaimed, a second jackpot ("Jackpot 2") will commence at \$20,000 on the next draw day and will increase by \$1,000 on each subsequent Wednesday and Sunday draw day.  
While Jackpot 1 is capped at \$100,000, only Jackpot 1 is available to be won at any given time. Jackpot 2 will continue to accumulate but cannot be won until Jackpot 1 has been claimed.  
If Jackpot 1 is claimed at any amount (including \$100,000), the next scheduled draw day will commence at the value of Jackpot 2 (if applicable), or at \$20,000 if no Jackpot 2 is in effect.  
The active jackpot will then continue to increase in accordance with these terms.
6. Should a jackpot be won at any one draw time, all subsequent draws on that day will be cancelled and the jackpot will reset on the following draw date.
7. The "prize" will consist of a cash jackpot.
8. The Members Badge Draw will be conducted as above until the expiry of the above Authority No. (15 April 2027) or on submitting an amendment application to NSW Fair Trading, whichever comes first.

### The Draw

Prior to each Members Badge Draw, a random number generator (Aristocrat Raffle Draw Number Generator) will be drawn on stage in the Sapphires Lounge area.

Numbers are automatically entered into the generator from System 7000 once they are on the system.

The person conducting the draw can either randomly choose a participant from the audience to trigger the start of the random number generator or start the random number generator themselves.

The Aristocrat Raffle Draw Number Generator will only select financial members.

The draws of the Members Only Badge Draw will be announced on the Club's public announcement system to all areas of the Club, except the Saints Sports Bar.

Winners must be on the licensed premises at the time of the draw and present themselves to the promotional host within 4 minutes to claim their prize.

It is the member's responsibility to:

1. Position themselves at the time of the draw in an area of the Club where the announcements are broadcast and where they can satisfactorily hear the public address.
2. Position themselves at the time of the draw in an area of the Club where they can physically present themselves to the promotional host within 4 minutes, should their name and membership number be drawn.
3. The Patron must present their (financial) physical or digital membership card to claim the prize.

Payment of prizes will be in the form of cash up to \$5,000 only, with the balance being paid by EFT to a nominated and verified bank account. Payment will be made at the time of the draw for cash component if requested, or the next business day for all EFT payments.

There will be no draw on Christmas Day – Monday 25<sup>th</sup> December 2023. The jackpot will sit as the same amount from the previous draw.

Terms and Conditions:

- To be eligible to claim the prize members must produce a current St Marys Rugby League Club membership card or Government issued photo identification.
- Persons must become a member of the Club each Sunday before 1:30pm and Wednesdays before 3pm to be eligible to claim the prize on that day.
- If government issued photo identification is produced an employee of the Club must cross check the name and address of the person to the Club's membership database prior to the prize being awarded.
- The cross-checking process does not have to be conducted within the four-minute time barrier as long as the person has fronted at the place of the draw and produced identification within four minutes.
- Persons who are not financial members or are barred or suspended members at the time of the draw are not eligible to participate.
- All employees of St Marys Rugby League Club are not eligible to participate in the promotion at any time.
- The Board of Directors of St Rugby League Club are not eligible to participate in the promotion. Family members of The Board of Directors (their wives, children and immediate family) are not eligible to participate in the promotion.
- All contractors and subcontractors of St Marys Rugby League Club, and their employees, are not eligible to participate in the promotion if they are working on a rostered shift or carrying out duties at the time of the draw.
- Partners and direct family members of the Clubs' Management Team are not eligible to participate in the promotion.
- Winners must be on the licensed premises at the time of the draw and present themselves to the promotional host within 4 minutes to claim the prize.
- It is the patron's responsibility to:
  - Position themselves at the time of the draw in an area of the Club where the announcements are broadcast and where they can satisfactorily hear the public address.
  - Position themselves at the time of the draw in an area of the Club where they can physically present themselves to the promotional host within 4 minutes, should their ticket be drawn.
- It is a condition of entry that winner's names will be advertised on the Clubs website \*
- It is optional if prize winner wishes to have a photo of them advertised on the Clubs website.
- The promotion will be scrutinised by an independent person- who is not the person conducting the draw and not an employee of St Marys Rugby League Club.
- St Marys Rugby League Club will have final say on all disputes and issues. Disputes must be received in writing to the Chief Operating Officer, St Marys Rugby League Club within 1 week of the alleged time of dispute.
- If the promotion system fails to operate, the draw will be conducted on the reception, cashier, or Duty Mangers computer, however there will be no access to display the draw around the club. There will be numerous PA announcements made to ensure patrons are made aware of the number being drawn.
- Each backup device will have the web link installed on the web browser, followed by a 'How to Guide' located in the Duty Manager's office.
